NATIONAL OFFICE ACTION ITEMS

NOCVA RECEIVES NON-PROFIT STATUS

In September, NOCVA national office received the good news that the application to function as a non-profit organization has been approved. Effective 1 November 2012, NOCVA is exempt from Federal income tax under section 501(c) (3) of the Internal Revenue Code, and classified as a "public charity."

This new status presents additional requirements:

- To include NOCVA chapters under the organization's non-profit status, NOCVA will need to request that the IRS consider NOCVA under a "group ruling." This request will be an addendum referencing the relationship between the national organization and the chapters.
- Each chapter will need to file for its own individual EIN number (by state).

NOCVA national coordinators will be sending regional coordinators specific information regarding the new requirements, along with a copy of the compliance guide for 501(c)(3) Public Charities.

Terri Guevara Smith Appointed to VA Advisory Committee for Minority Veterans

Terri Smith has been appointed by Veteran Affairs Secretary Eric Shinseki to serve on the VA's Advisory Committee for Minority Veterans. Committee members represent various minority groups (Asian Americans, Hispanic Americans, African Americans, as well as Pacific Islander Americans) and provide advice to the Secretary on the needs of minority veterans regarding health care, rehabilitation benefits, compensation, outreach, and other programs administered by the VA.

In addition to her advocacy for Pacific Islanders, Terri also serves as the Senior Adviser to NOCVA for Chamorro Women Veterans and Regional Coordinator, Maryland Chapter. In her role on the VA committee, Terri will be representing Pacific Islander veterans to ensure that their needs and concerns are raised and considered. Should official documents/policy implications result from work done by the committee, Terri will provide status reports to NOCVA national coordinators, who will then communicate as necessary with regional coordinators.

Terri has a long history of supporting Chamorros and other Pacific Islanders. We are proud of Terri for being selected for this honor and extend our congratulations and best wishes to her!

Terri Guevara Smith

Teresita "Terri" Guevara Smith was born and raised in Ordot, Guam, to Juan Gogo Guevara (Kalu) and Teresita "Cid" Cruz Cruz (Fungo); she is one of nine children. She joined the U.S. Army in 1975 and retired after 22 years of service in 1997, as a Sergeant First Class. After retirement from the Army, Terri worked as a DOD contractor and Civilian Intelligence Officer. She currently works as a federal civilian employee for the Department of Defense in Washington, D.C.

Terri graduated from George Washington High School and attended the University of Guam. Her military career spanned 1976 to 1997, with tours in Germany, Maryland, California, and Washington D.C. As a DOD civilian, Terri received one of the highest honors in Military Intelligence, the "Knowlton Award," awarded by the Office of the Director of National Intelligence for her work in the DOD Open Source Intelligence Collection Management Program, and its system architecture.

Since 1993, she has been an active member of the Guam Society of America in Washington, D.C., serving in various leadership roles. Terri and her family live in Upper Marlboro, Maryland.

Frank Flores Honored for Outstanding Service by NOCVA's North Carolina Chapter

Frank Flores, who recently joined NOCVA's efforts to establish a program to help Chamorro veterans navigate the complicated VA claims process, was honored by NOCVA's North Carolina Chapter, Fayetteville, in June for his work as the Founder/Mentor of Project Guiding Light Veterans Volunteer Advocacy Group (PGL).

According to **Tony S. Duenas**, NOCVA NC PGL Coordinator, Frank's dedicated service to Chamorro veterans has earned him the respect and title as "VA Resident Expert"; particularly noteworthy is the fact that out of 24 claims submitted for benefits to date, 15 veterans have received 100% compensation.



Frank H. Flores

Frank H. Flores (a.k.a Apo, Cabeza, and Tagasi) was born in 1950 in Agana, Guam. From birth, Frank was raised by his grandmother, Ana Flores, and by his parents, the late Francisco San Nicholas Flores and Mercedes Guerrero Flores, formerly of Barrigada and now Ipan. He graduated in 1968 from George Washington High School. He enlisted in the U.S. Air Force and retired in October 1990 at Los Angeles Air Force Base (Space and Missile System Contracting Division) as a Master Sergeant. Frank retired after 22 years of military service; four months later, he returned to the work force.

In January 1991, he was hired as a GS-7 Trainee Veteran Benefits Counselor (VBC). He was promoted to GS-9 the following year and then to GS-10 Temporary VBC Lead Counselor. Three years into his tenure at the Los Angeles VA Regional Office, he was promoted to GS-11 as one of two Public Contact Representative Supervisors at that station. On his fifth year, he was nominated, certified, and selected as a Rating Officer, GS-12, where he started his career in decision making at one of the largest VA Regional Offices in the nation. He performed various duties such as Field Service Counselor for the Transition Assistance Program (TAP), covering Barstow Marine Corps Base and Fort Irwin Army National Training Center for Desert Warfare.

He volunteered for and was selected as the VA Regional Office (VARO) POW Assistant Coordinator and Assistant Senior Rating POW Officer under the direction and supervision of the Senior Rating and Training Officer at that station. He was selected for and managed the VARO Congressional Liaison Office with a staff of two. Other duties followed until he was certified for and selected to a pilot program for Senior Rating Officers (184 slots nationwide) as part of the VA Decision Review Officer (DRO) Program, GS-13. Frank was the first Chamorro VBA employee to be selected for this new and continuing program of appellate review. As a DRO, he was responsible for appeal cases in his assigned jurisdiction for a final review and decision prior to cases being certified and transferred to the Board of Veteran Appeals (VBA).

Frank retired from the VA and founded Project Guiding Light Veterans Volunteer Advocacy Group to bring attention to the plight of many veterans who were caught in the complex process involved in VA claims processing. He is now the Technical Consultant on VA Benefits and Federal/ancillary benefits and services for NOCVA. Frank lives in Las Vegas, NV.
